Preserving our Built Heritage — The Aylmer Experience

The Society is pleased to welcome **Mr. Richard Bégin**, former President of the Aylmer Heritage Association (AHA), who will present a historical retrospective of the AHA's activities in terms of working with the Municipality of Aylmer to create by-laws, plans, and best practices for heritage buildings preservation and architectural integration. Richard Bégin is President of Symmes Inn Museum and currently sits on the Gatineau Urban Planning Committee. Victorian Era Railway Stations and Bridges in and around the Gatineau: Remembering and Preserving our Heritage

Bytown Railway Society member Mr. David L. Jeans will talk about the railway stations and bridges built along the railways around Hull in the years from 1877 to 1901. His presentation will show how these were all related through their builders and a common late Victorian Italianate architectural style. He will also talk about the lost stations of that era that are closely related to the survivors, namely Chelsea, Low, and Kazabazua on the Maniwaki sub. Davis Jeanes is President of Transport 2000 Canada, vice-president Heritage Ottawa, and member of Ottawa Railway History Circle, Ottawa Valley Associated Railroaders, Bytown Railway Society, and Ottawa Valley HOTRAK modular railroad club.

# The Tools of Heritage Conservation

Congratulations should be extended to both the • Municipalities of La Pêche and Chelsea, which have both recently taken recent action to recognize and protect important heritage monuments within their • jurisdiction.

Last spring the Municipality of Chelsea assumed ownership of the **Old Chelsea Protestant Burial Ground** and agreed to look after its maintenance. Furthermore, Chelsea recently launched its new **Culture and Heritage Policy** which among other things, recognizes that the Municipality "has a collection of sectors and sites with unique identity, and that should be developed and maintained".

In La Pêche, the municipality has recently taken ownership of the **William Fairbairn House** and covered the cost to move it to Hendrick Park, where it will be turned into a local history museum. As well, the **La Pêche Heritage Building Recognition Program** continues to add more centenary buildings to its inventory every year. (See item on page 4).

However, good intentions are not always enough! Although both municipalities have taken an interest in "recognizing" historic sites, neither municipality has taken the extra steps required to protect these sites from incongruous development by introducing tools to "classify" building or areas for heritage protection.

As our historic villages face the pressures of rapid development, it may be time for our Municipal governments to create the laws and standards that are required to ensure the protection of our significant heritage buildings or sites.

The following is a summary of some of the ways heritage buildings and areas can be protected at the municipal level.

In 1985, the **Quebec Cultural Property Act (CPA)** of 1972 was modified to give municipalities the right • to protect their own heritage. It allows for 5 principal categories of classification ensuring various degrees of protection on buildings or sites:

- Historic monument: An immovable which has historic interest because of its use or architecture. A classified monument can also have a protected area which is an area surrounding a classified historic monument whose perimeter is determined by the Municipality.
- Historic district: a territory designated as such by the municipality Government because of the concentration of historic monuments or sites found there.
- Historic site: a place where events have occurred marking the history of Quebec or an area containing historic property or monuments.

- Archaeological property: any moveable or immovable property indicating prehistoric or historic human occupation.
- Natural district: a territory designated as such by the Government because of the aesthetic, legendary or scenic interest of its natural setting.

In Quebec, municipalities have two means to conserve their heritage: urban planning by-laws and the powers given to them by the CPA.

- According to the CPA, a municipality may form a Heritage Advisory Committee whose function is to give its advice to the council of the Municipality on any matter relating to the administration of the CPA. (La Pêche currently has this committee)
- After obtaining the advice of the advisory committee, a municipality may, by by-law of the council and after giving public notice, designate all or part of a historic monument, site, or district situated in its territory, the conservation of which is in the public interest.

A master plan is a long term planning tool. Some of its by-laws can allow for heritage conservation and may include conditions to ensure that every designated historic monument shall be kept in good condition and that no person may demolish all or part of a designated historic monument, move it or use it as a backing for a construction without the authorization of the council.

Every person who in any way alters, restores, repairs or changes the exterior appearance of a designated historic monument shall comply with the conditions relating to the conservation of the characteristics of the monument to which the council may subject them in addition to the municipal by-laws.

A municipality can require that developers submit for approval drawings for a proposed project that show the architecture of the building, how it is laid-out and how it integrates into the surrounding neighbourhood. This law, called a plan d'implantation et d'intégration architecturale (PIIA), is based on certain criteria and covers an area defined by the municipality.

There are many tools available for municipalities to protect its heritage. In fact these kinds of protection have become common in many Quebec municipalities that have recognized the important role that heritage plays in the prosperity of their communities. With the November municipal elections around the corner, Society members may want to ask La Pêche and Chelsea candidates about how far they are willing to go to protect heritage sites and buildings.
