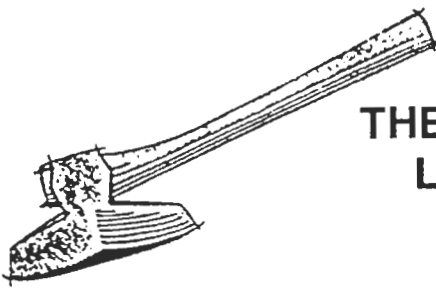

The sequel to *Historical Walks: The Gatineau Park Story*, Katharine Fletcher's new book, *Capital Walks*, describes a series of interesting historical tours in the national capital.

Capital Walks deals with eight areas of historical interest in the Ottawa area: Parliament Hill, Sussex Drive, Lower Town, New Edinburgh, the Rideau Canal, the Glebe, Sandy Hill, and Rockcliffe. Each section features a history of the neighbourhood, a map indicating the landmarks, descriptions of the architectural style, and excellent photographs.

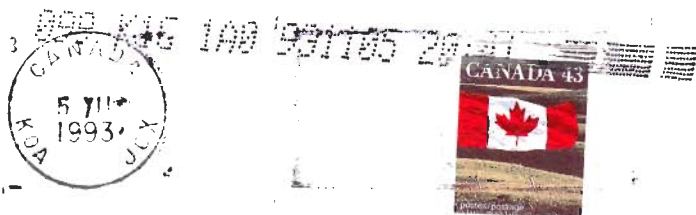
